

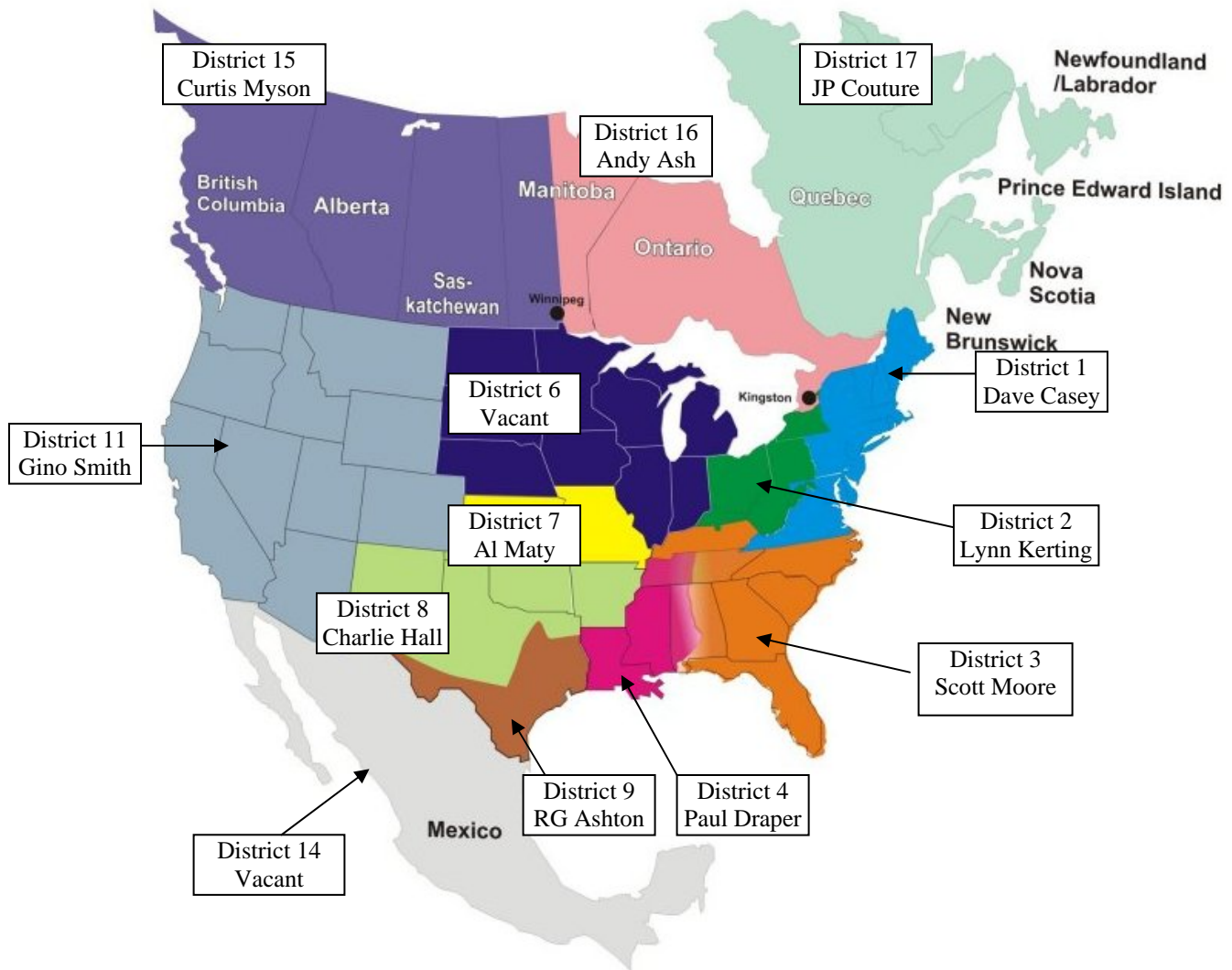
Bureau of Explosives Department Contacts and Primary Areas of Responsibility
